Erasmus+ so far - 1

Positive impacts

Bottom up approach

*Success of **curriculum development**, new fields of study (environment, renewable energies, biotechnologies...)*

Modernised teaching methods and learning processes

In line with Bologna (ECTS, degree structure, learning outcomes...)

QA mechanisms and assessment methods

Structured training in soft skills as part of curricula

Closer relation with the world of work

To be improved

Impact at national level, link with national reforms, links with HEREs

"Pioneer efforts"

Risk of simple copy/pasting

Still resistance towards more student-centred approaches

Some difficulty to meet the demand (i.e. language problem)

Strong focus on hard sciences, not enough on social sciences (link with political priorities: democratisation, rule of law, fight against corruption, inter-cultural dialogue...)

Positive impacts

University business cooperation, high variety of activities

Involvement of employers, civil society

Need to check legal and financial constraints before applying

Need to improve communication with employers, job fairs, work placements, offer applies solutions to enterprises

Tracers studies to provide evidence

Erasmus+ so far - 4

Positive impacts

*Development of **internationalisation** strategies that go beyond mobility*

Erasmus+ offers large variety of options that can lead to other type of cooperation (research)

Staff mobility

Mobility in both directions

Individuals involved in projects move up the academic ladder

Need for institutional strategies, support from management, not only individual approaches

More joint and double degrees

But rigid national legislations

Internationalisation at home



Make education offer more attractive and visible, in EN

Over 10,000 mobilities funded with Eastern Partnership countries in 2 years




Where are participants from Eastern Partnership countries going to?




More balanced geographical coverage...

- ✓ Smooth recognition process


Challenges

- ✓ Poor communication between partners
- ✓ Lack of established management structures at Partner Country HEIs
- ✓ Insurance & visa issues
- ✓ Language skills


For the ongoing call

- ✓ More inclusive development: need to involve new HEIs, in more remote areas, from less favoured backgrounds
- ✓ One application deadline: 2 February 2017 (16 or 26 months projects)
